Article III of the Constitution of the Faculty and Bylaws of the Academic Senate states inter alia:

Section 2. Powers and Responsibilities of the Academic Senate

Joint decision making and consultation between the administration and the

General Faculty have been recognized by the legislature of the State of California
as the long accepted manner of governing institutions of higher learning and are
essential to the educational missions of such institutions. In order to participate
fully in the process of joint decision making and consultation with the
administration, the Academic Senate is empowered to exercise all legislative and
advisory powers on behalf of the General Faculty. These legislative powers shall
include all educational matters that affect the General Faculty (e.g., curricula,
academic personnel policies, and academic standards). Advisory powers shall
include, but not be limited to consultation on budget policy, administrative
appointments, determination of campus administrative policy, University
organization, and facilities use and planning.

It is my understanding that the legislative and advisory powers of the Senate are co-equal, and I believe that this committee is one of the most important of the Senate's standing committees.
