Quarterly Report, Fall 2013

The ASCC physically met six of the eleven weeks in addition to two e-meetings for minor business.

GENERAL BUSINESS

In addition to the specific Policy and Courses described below, we also spent meeting time working with campus constituents to improve the curriculum review process.

- **Course Inventory Managements and e-Workflow.** We provided formative feedback for the new Course Inventory Management system and electronic workflow.
- Curriculum Development Guiding Principles Document. We developed a guiding principles document to be shared to with the campus community Winter quarter that provides helpful tips for faculty who are developing curriculum. The document also aims to guide departmental and college reviewers so that their review process can better remedy common problems early in the review process. The ASCC chair, Andrew Schaffner, and the Associate Registrar, Susan Olivas, have scheduled individual meetings with all college curriculum committees to discuss the ASCC review process as well as provide suggestions for their review processes. These meetings will be held in January, 2014.

POLICY

This quarter we developed and presented three resolutions to the Executive Committee:

Resolution on Graduate Certificate Matriculated Student Requirements. This
resolution was agendized and was under a first reading on December 3, 2013. The focus of
this resolution is to limit the number of units earned by non-matriculated students that can
apply to graduate certificates.

- Resolution on Inactivating and Reactivating Courses. This resolution was agendized and
 will undergo its first reading Winter Quarter. The focus of this resolution is to provide a
 policy and mechanism to inactivate courses that have not been taught in the past six years
 and prevent them from appearing in the catalog. The resolution also provides a method to
 reactivate courses without needing to follow the full course proposal process.
- Resolution on Cross-Disciplinary Studies Minors. This resolution was agendized and
 will undergo its first reading Winter Quarter. The focus of this resolution is to establish a
 new type of minor that emphasizes focus within a target discipline and depth in partner
 discipline and mutual domain of the target and partner.
