Review GETF report and prepare resolutions, where appropriate, for GE revision. Fall 2019		The potential for pathways within GE will be the likely topic stemming from the GETF report, and discussion of this will begin in winter quarter.	
Review curriculum proposals (catalog cycle and continuous course proposals). Ongoing		A request to review two course proposals on a special cycle produced an unusually involved discussion. Due the pressing need to make progress on the GE Area guidelines, the Board was able to provide substantive feedback on only one of these proposals this quarter. The second in the pair, along with about a half dozen other proposals currently in the workflow, will be reviewed this winter. In addition, the chair undertook many special requests to review study-abroad courses for their appropriate GE credit. The chair also issued extensions to the GE credit offered by courses in many international programs. This was necessary as formal review of these courses is on hold until new area guidelines are approved.	

Explore "course renewal" cycle (in tandem with ASCC). Ongoing	In winter, GEGB will send a representative to the Senate's taskforce on this topic.
Guide GE Area Workgroups and D&I Workgroup. AY 2019-2020	With the approval last year of the new guidelines for Areas A and B, those workgroups have been disbanded. Before submitting a final draft of the Area C, D & E Guidelines Resolution, the GEGB consulted the Area C and Area D/E workgroups for their input. Upon approval of the new guidelines in those areas, these groups, too, will be disbanded. With Senate consideration this quarter of the resolution to revise USCP learning objectives, the D&I workgroup was involved in modifications between first and second readings. As the Senate passed this resolution, the D&I workgroup has one remaining proposed resolution on the possibility of modifying the USCP requirement to include one upper- and one lower-division component.
Revise GE PLOs. AY 2019- 2020	This discussion is expected to occur in spring.

NOTES:

- The overwhelming majority of the Board's time this quarter was spent on revising the GE Area C, D & E guidelines for GE 2020. This was completed at the end of the quarter, and the corresponding resolution was sent to the Senate's Executive Committee for consideration.
- In collaboration with the Registrar's Office, GEGB developed a multi-year timeline for implementing the new GE template and re-certifying all GE courses under the new guidelines.
- Communiqués have been and will continue to be sent out this year reminding the campus of important deadlines in the course re-certification process.
