During the Winter term (2010) the Academic Senate Grants Review Committee met on Saturday, February 27, to evaluate twenty-four Student Research proposals for the Twenty Fourth Annual Student Research Competition to be held on April 30<sup>th</sup> and May 1st at San Jose State. Although twenty-four students submitted proposals (a record number for this event), one student dropped out at the last minute leaving a total of twenty-three presentations. Each presentation was for fifteen minutes with a five-minute question period. The committee ultimately chose the ten proposals listed below for entry into the final competition.

This committee is also charged with evaluating State Faculty Support Grant (SFSG) proposals. However, due to budget cuts, no awards were funded from the prior year (2008-2009). Despite these cuts, there has been no definitive statement about the future of the program and the Office of Research and Graduate Programs has solicited proposals for the 2009-2010 period with the assumption that the program will eventually receive funding. Thirty seven proposals have been received and the committee plans to meet at least once in the Spring term to (1) set a policy for the order of priority for 2009-2010 awards (awardees who did not receive funding from 2008-2009 will likely be given the highest priority if money becomes available), (2) evaluate the current set of proposals.
