The Committee met five times during Fall quarter. An informal work plan for 2012-2013 was developed based on input from the Executive Committee of the Academic Senate and agenda items for meetings were generated consistent with the work plan. - Bob Echols' "Sustainability Learning Assessment" will be turned into a Survey Gizmo online survey so that those committee members wanting to use it can send it out to students without having to develop their own assessment or to use class time to administer the survey. In addition to the questions, an introduction will be written along with some demographic questions (major, college, year among others) so that the info can be easily sorted Katie Tool will work on setting up the survey and will send it out for review within a week; Neal will draft a two sentence introduction that can be incorporated into the survey and the accompanying email. [Note: the draft survey will be shared with the adjunct/interested non-committee members for any feedback they might have.]
- The committee will finalize the survey no later than the next meeting (possibly at the next meeting) on Monday February 11<sup>th</sup>.
- Members of the committee will identify classes, colleagues, groups that can take
  the online survey or an assessment instrument of their own design. Everyone
  can choose their own approach Everyone administering the non-online
  survey will be expected to report back results by the Friday March 1st
  meeting of the committee
- 3. Briefly discuss Pete Schwartz's request for support of formally incorporating sustainability into the RPT process for the College of Science and Math (attached).
  - The committee discussed the issue of incorporating sustainability into the RPT process. The working idea emerging from the group was to provide support for a statement that recommends that the RPT process focus on showing a commitment to the ULOs (of which sustainability is a part) which provides the opportunity for departments and colleges to have a discussion of what they might want to emphasize.
  - A comment was brought up that there have been instances where departments have felt a need to choose one emphasis area over another for RPT. Specifically, that a department recognized that diversity and sustainability hold similar positions of importance within university priorities but that the department chose to focus on diversity only.
  - The committee will address online (via email) a draft statement of approximately two-three sentences reflecting the above conversation for final determination of how to respond to Pete - Neal will draft the statement and send out via email by the end of next week.
