# CURRICULUM REFRESH

The ASCC recognizes the need to ensure that the courses we deliver are aligned with the courses that were approved. Since many courses do not have course learning objectives on file, or have very old objectives, we began to explore processes to maintain a database of <u>current</u> learning objectives for all courses. Because of the current campus climate and perceived faculty dissatisfaction and workload, we hesitate to propose any ideas that would increase the responsibilities of faculty or departmental staff. Nonetheless, some ideas that *could be considered in the future* when climate improves and additional resources are available include the following.

- Regular (6 year cycle) required validation and, if needed, updating of course learning objectives. Courses not validated/updated would be suspended until they are updated.
- Validation may include departmental review of course materials and course syllabi from a variety of faculty who teach the course.
- Consider expedited processes to avoid additional workloads for college and university level curriculum review, especially for minor edits.
- Couple this process with program review, but delay any implemented changes until the subsequent catalog cycle.
