Develop a comprehensive General Education assessment plan aligned with university-wide assessment efforts, in preparation for a later GE program review. Ongoing	Ongoing	The chair has continued to work with Academic Programs to develop a comprehensive GE assessment plan. The chair has also met with Dawn Jenke and Jennifer Teramoto Pedrotti about their core competency studies and collaborated with Academic Programs on the upcoming quantitative analysis core competency faculty lead. The chair met with each member of the GEGB individually to talk about the developing assessment approach and its guiding principles. Currently, the GEGB intends to partner with campus stakeholders to be the body that curates and analyzes GE assessment data and to create an externally facing website to document the GE program.
Continue to support the Q2S conversion on GE policy and draft revision plans as needed. Ongoing through conversion	Ongoing	From Summer 2025 to the present, the GEGB chair has continued to develop guidance and a memo for the Registrar's Office on "transition decisions for GE 2026." The chair has also worked with the Registrar's Office on messaging to students who need Area E courses and wish to remain on CSU GE Breadth. On two occasions, the chair asked the Senate Office to send communications about the GE changes, including a webpage the Registrar's Office developed. The chair has worked with the Registrar's Office, Academic Programs, and the chair of the Academic Senate Curriculum Committee to implement the Chancellor's Office guidance on which GE areas to award credit for passing the AP, IB, and CLEP exams. Finally, the chair has continued to work with the International Center to approve study abroad programs and course substitution requests.
