6 7 8	WHEREAS,	AS-3171-14/AA also recommended that the CSU campuses consider adopting policies determining whether a course is "designed primarily for graduate study"; therefore be it
9 10 11 12	RESOLVED:	That a graduate course be defined as a course designed primarily for graduate study following the guidelines proposed in EP&R 82-39, coded memo on "Definitions of Graduate Level Instruction," dated August 12, 1982; and be it further
13 14 15 16 17 18	RESOLVED:	That a graduate course be further defined as a stand-alone course at the graduate level (i.e. not scheduled to meet at the same time, or in the same place as an undergraduate or teaching credential course with the exception of service courses which, if they were to be taught within the student's home department, would typically receive graduate credit); and be it further
19 20 21	RESOLVED:	That the requirement for the number of units designed for graduate study be elevated from 50% to 60% of the units required for the degree; and be it further
22 23 24	RESOLVED:	That these requirements be implemented by all graduate programs no later than the 2019-21 Cal Poly Catalog cycle.
