RESOLUTION on Grade Forgiveness and Course Repeats effective Fall Term 2026

Impact on Existing Policy: Align the Cal Poly policy on grade forgiveness and course repeats with CSU Executive Order 1037.

1 2 3 4	WHEREAS,	AS-702-10 Resolution on Grade Forgiveness established that students be permitted to repeat up to 16 units for grade forgiveness in courses that they earned grades of C -, D+, D, D - , F, or WU (Quarter Units); and
5 6 7	WHEREAS,	Currently, students may repeat up to 18 units of courses, in addition to the 16 units for grade forgiveness, for a total of 34 quarter units; and
8 9 10 11	WHEREAS,	Once students accumulate 34 quarter units (16 units with forgiveness + 18 units with averaging) of repeated courses, they are no longer allowed to repeat any future courses for forgiveness or averaging; and
12 13 14 15 16 17 18 19 20 21 22	WHEREAS,	CSU Executive Order 1037 on "Grading, Repetition of Courses, Academic Renewal, and Appeals Policy" states that: undergraduate students may repeat up to 16 semester-units (24 quarter-units) with grade forgiveness, that undergraduate students may repeat an individual course for grade forgiveness no more than two times, and that grade forgiveness shall not be applicable to courses for which the original grade was the result of a finding of academic dishonesty. Further, undergraduate students may repeat an additional 12 semester-units or 18 quarter-units where the repeat grade does not replace the original grade but instead both grades shall be calculated into the student's overall grade-point average.
23 24 25	WHEREAS,	Campuses may elect to be more restrictive on course repeats than the maximum listed in CSU Executive Order 1037.
26 27 28 29	WHEREAS,	Currently 21 CSU campuses allow grade forgiveness and course repeats up to the maximum cited in CSU Executive Order 1037 (exceptions CP-SLO [16+18], CSUSB {12+30}); therefore be it

31	RESOLVED:	That the Academic Senate of California Polytechnic State University, San Luis
32		Obispo supports amending the policy for grade forgiveness/course repeat up
33		to the maximum cited in the provisions of CSU Executive Order 1037 allowing
34		for 16 semester-units for grade forgiveness and 12 semester-units for course
35		repeat for a total of 28 semester-units; and be it further

37	RESOLVED:	That this provision become effective beginning with the Fall term of 2026.
