CAMPUS PUBLIC SAFETY ADVISORY COMMITTEE

Function

The national conversation on race, social justice and policing has elevated student, faculty, and staff concerns about law enforcement on university campuses. As a result, the California State University (CSU) adopted the Campus Police and Safety Advisory Committee policy requesting campus presidents to establish an advisory committee to review campus police and safety matters that affect students, faculty, staff and visitors. This includes the implementation and enhancement of community policing principles and practices that uphold transparency and enhance trust of campus law enforcement agencies.

In 2015, former President Obama established the Task Force on 21st Century Policing to address exposed rifts in relationships between police and the communities they protect. He charged the task force with identifying best practices and offering recommendations on how policing practices can promote effective crime reduction while building public trust. The task force recommendations are organized around six main pillars: Building Trust and Legitimacy, Policy and Oversight, Technology and Social Media, Community Policing and Crime Reduction, Officer Training and Education, and Officer Safety and Wellness. These pillars were adopted by all 23 CSU campuses as a working guide for instituting meaningful change and improvements across the university.

The purpose of the Public Safety Advisory Committee is to promote and embrace a shared responsibility for campus safety, consider all dimensions of safety, promote improved communication, advance relationships and safety throughout campus and increase awareness of safety conditions and programs.

The Committee will assist the Public Safety units understanding of campus community members' experiences, needs and perspectives while serving in an advisory capacity to the University President. Committee members will use their varied expertise and areas of specialization to offer sound counsel in the administration of public safety practices on campus. They will also assist in educating the Cal Poly community about programs, services and initiatives offered by Cal Poly Police and Public Safety. The committee is comprised of a diverse group of campus community members who will review and provide counsel on matters of public safety to create a welcoming, safe and inclusive campus environment for our students, faculty and staff. The advisory committee may not be authorized to receive, review, or investigate complaints against university employees or students.

Terms

Committee members are appointed to one-year terms and shall not serve more than three consecutive years. Exceptions include the Assistant Vice President of Student Affairs Diversity and Inclusion and Assistant Vice President of Public Safety/Chief of Police as committee cochairs
