Job Title: Assistant Growing Manager

Summary Assistant Grower helps oversee the daily operations by managing the care of vegetables, ornamental plants, trees, shrubs, or flowers for wholesale customers by performing the following duties personally or through subordinate supervisors. Every position in production is fast-paced and requires a high-energy individual who is a self-starter with a positive attitude and is eager to perform to the best of their ability.

Essential Duties and Responsibilities include the following. Other duties may be assigned.

- Works with the Head Grower to determine growing conditions, considering such factors as whether plants will be grown under controlled conditions in greenhouse or under natural weather conditions.
- Selects and purchases plant nutrients, and disease control chemicals according to type of plants and conditions under which plants will be grown.
- Tours work areas to observe quality and quantity of work being done, to inspect crops and to evaluate horticultural conditions such as fertilizing, plant disease and overall health of the crop.
- Work closely with the Head Grower on the overall operations of the department.
- Assist with manpower needs to supplement other departments
- Recommend, implement, and support continuous improvement within the department and the company to improve employee performance, quality control, productivity, efficiency, and cost reduction.
- Support a proactive safety environment, with emphasis on good housekeeping techniques.
- Pesticide mixing and application while wearing label required PPE
- Assists Grower and coordinates activities of workers engaged in growing activities.
 - Manages up to 20 employees in the Growing Dept.
 - Carries out supervisory responsibilities in accordance with the organization's policies and applicable laws.
 - Responsibilities include training employees; planning, assigning, and directing work; appraising performance; motivating, recognition, rewarding and disciplining employees; addressing complaints and assisting in problem solving.
 - Provide follow-up to ensure that tasks are completed timely, efficiently, and in a knowledgeable manner.
- Perform various other duties as required
