This position plays a vital role in strengthening youth involvement in the livestock industry through innovative programming, strong partnerships, and statewide outreach. This position is located in [Brookings](#), South Dakota. This position is a 12 month, full-time, benefits-eligible position.

Kids experience 4-H through in-school and after-school programs, school and community clubs and 4-H camps. - Support the livestock industry by creating programming that aligns with current and future workforce and educational needs.

The minimum starting salary is \$55,339.
