### **Cal Poly Establishes Center to Better Understand Cultural, Demographic Landscape of Central Coast**

A group of faculty members has established The Center for Applied Study of Place-based Indigeneity, Race and Ethnicity (ASPIRE) to further understand the cultural and demographic landscape of Cal Poly and the Central Coast, provide research-based support for historically underrepresented communities on the Central Coast, and support Cal Poly's diversity, equity and inclusion efforts through sustained positive impacts on the surrounding communities. Jenell Navarro, interim department chair of the Ethnic Studies Department, will serve as director of the ASPIRE Center. The research team also includes Denise Isom, interim vice president of Diversity and Inclusion; José Navarro, associate professor of ethnic studies; and Grace Yeh, professor of ethnic studies and interim chair of the Communication Studies Department. The research team aims to investigate and uncover the histories of indigeneity, racism and white supremacy in the region and the state; highlight the significant and ongoing contributions by people of color and their partners on the Central Coast and throughout the state; and engender and maintain greater equity and access at Cal Poly and across the Central Coast.

### **Flu Vaccinations Offered to Employees on Sept. 28**

Campus Health and Wellbeing has partnered with Rite Aid Pharmacy to bring a flu vaccination clinic for employees to campus, as part of an ongoing effort to promote health and well-being across our community. On Monday, Sept. 28, Rite Aid will be on campus to administer flu vaccinations to any Cal Poly employee and their eligible dependents (age 3 and up) from 10 a.m. to 2 p.m. in the UU Plaza. The high-dose vaccine for individuals over the age of 65 will also be available. Employees may use their insurance benefits (bring your insurance card) or pay \$28 for the vaccination.
