Course Description

Applications of strategic management techniques and business strategy for managing and longrange planning of the construction firm. 3 activity

Course Goals and Learning Outcomes

Course Goals:

As a result of this course, you should be able to:

- Understand and comprehend the principles of assembling and managing a construction firm
- Examine and define a set of construction firm's ethics and how they effect our industry

This course examines management functions, interpersonal management skills and leadership knowledge capital as they relate to the operations and management of a construction organization. The course includes an overview of current topics, and industry trends as they relate to today's vast growing construction industry. Students will be exposed to the aspects that effect construction firm management success such as the planning and scheduling process; financial risk management; construction economics; contract administration; construction safety and health issues; applications of construction business and management principles; ethics and diversity concerns; human resource management; labor relations and union issues; the importance of a quality control and quality assurance plan; bonding and insurance. We will discuss business development and marketing principles, public relations, and brand imaging as they relate to growing a winning construction organization.

Course Learning Outcomes (CLOs):

- 1. Analyze and discuss the procedures, risks, challenges and benefits associated with starting a new construction business.
- **2.** Examine the concept of entrepreneurialism and discuss how it affects career decisions and business management principles.

- **3.** Analyze, compare and discus the various legal entities and organizational structures and considerations in developing a construction business.
- **4.** Comprehend and recall contractor's license law and how it affects the management of a construction firm.
- **5.** Comprehend and recall Mechanic's lien law and how it affects the management of a construction business.
- **6.** Examine and discuss corporate ethics and how it affects the management of a construction business including compliance with laws and regulations, fair hiring practices, sexual harassment, minorities, and diversity issues.
- **7.** Analyze and discuss labor relations and human resource management issues and how they affect the management of a construction firm.
- **8.** Analyze and discuss business planning concepts and how they affect the management and profitability of a construction business.
- **9.** Evaluate and develop a typical business plan for a construction related firm and assess its viability including evaluating and developing an income statement and balance sheet as it relates to a start-up construction firm.
- **10.** Analyze and discuss marketing and business development concepts and how they affect the management, profitability, and long-term success of a construction business.
- **11.** Analyze and discuss negotiation concepts and techniques and perform a negotiation for a construction related case study.
- **12.** Analyze and discuss the concepts, issues, and practices for dispute resolution commonly used in the construction industry.
- **13.** Analyze and comprehend the importance of a good quality control/quality assurance plan as effective management principals in construction business management.
- 14. Recognize and identify the importance of a establishing a company organizational safety plan.
- **15.** Analyze and discuss the importance of setting up environmentalism and philanthropy practices in running a successful construction firm.
- 16. Compare and contrast capital budgeting decisions based on evaluating alternative course of action.
- **17.** Identify and evaluate the responsibility of construction accounting issues to include the differences between cost centers, profit centers, and investment centers as it relates to a construction related business entity.
