### Method of Assessment:

Assessment utilizes two distinct surveys: one targeting industry employers and another for graduating students. The anonymous online surveys are administered in the spring, with graduating students participating annually and industry employers every other year. Survey data are systematically collected using an online platform (Microsoft Forms) to ensure comprehensive and accessible data management. The results are integrated into the evaluation process for all Program Learning Outcomes (PLOs), supporting informed decision-making and continuous curriculum improvement.

Because this assessment measure is not included on the ACCE list of required measures, utilizing two indirect assessment methods is recommended to effectively evaluate student attainment of this

The results indicate that both employers and students feel that Cal Poly construction management students understand the role construction managers play in enhancing the needs of society.

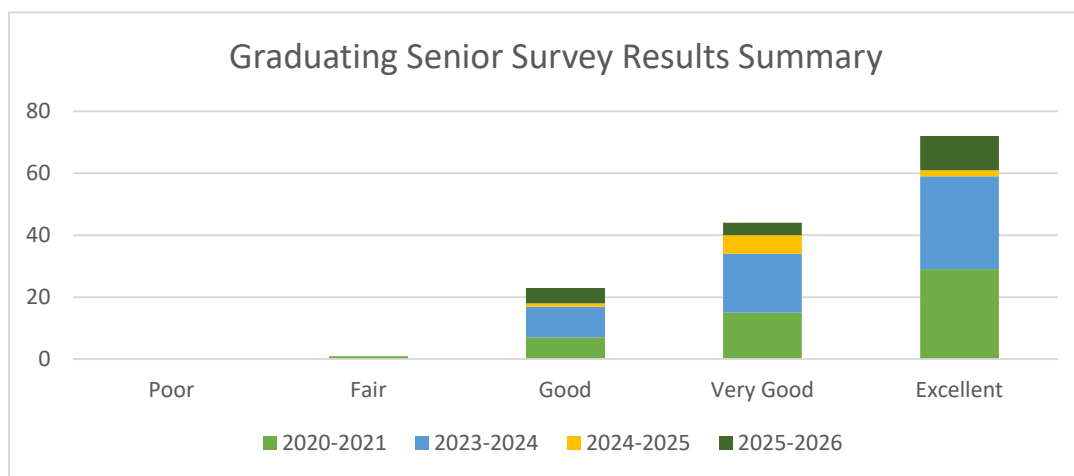
### Recommendations for Improvement:
