- The complete Application must be given to the Coordinator of Student Development prior to the guest staying in University Housing. Only completed original applications will be processed. Please DO NOT FAX or email.
- Minor guest must be in the company of their Cal Poly resident hosts at all times
- Minors 16 and older must also bring a license, passport, school ID or other form of photo identification.
- Minors under the age of 15 years old must be accompanied by a parent or legal guardian at all times while in University Housing.
- Hosts must also complete a Guest Registration Form with approval from all roommates or apartment mates.

The University Police Department will be contacted if there is a concern with any minor quest who does not have a consent form from a parent or legal guardian, is unaccompanied by the designated student host or is found in violation of campus policies or local, State and Federal laws.
