Campus Showcase Agreement Form 2018

NOW THEREFORE, in consideration of the mutual covenants set forth herein and for other good and valuable consideration, the sufficiency of which is acknowledged, it is agreed as follows:

- 1. <u>Term.</u> The term of this Agreement (the "Term") shall be from the date of its execution through April 14, 2018 unless sooner terminated by the parties.
- 2. <u>Fees & Fines</u>. In consideration for the benefits set forth herein, CLUB/ORGANIZATION shall provide CAL POLY with the Campus Showcase fees set forth in club packet. CLUB/ORGANIZATION agrees to pay any and all fines that may be incurred as not following Campus Showcase Policies. Fines may be appealed. No Refunds shall be issued.
- 3. <u>Financial Responsibility</u>. CLUB/ORGANIZATION agrees to utilize CLUB/ORGANIZATION funds to pay for any and all loss, damage, or liability that CAL POLY may suffer or incur that is caused by, arises out of, or is in any way connected with the OPEN HOUSE activities of this Agreement. This includes any fees established by CAL POLY.
- 4. <u>Law and Policy</u>. CLUB/ORGANIZATION agrees that it will adhere to any and all applicable state and federal laws and regulations as well as Cal Poly policies during its business, service and activities under this Agreement.
- 5. <u>Independence</u>. The parties to this Agreement shall be and act as independent parties, and under no circumstances shall this Agreement be construed as one of agency, partnership or employment between CAL POLY and CLUB/ORGANIZATION.
