

## **DISABILITY ACCESS AND INCLUSION COMMITTEE**

### **Function**

The mission of the committee is to discuss, monitor, and evaluate campus-specific issues relating to compliance with California State University Executive Order 926 (<http://www.calstate.edu/EO/EO-926.html>) and can be expected to produce Americans with Disabilities Act (ADA) compliance-related reports to the Chancellor's Office as requested.

As needed, DAIC members serve on the Accommodation Review Board (ARB) to resolve accommodation disputes in accordance with the "Student Policy and Procedure for Resolving University 504/ADA Accommodation Disputes" (<https://drc.calpoly.edu/content/support/legal/disputes>).

Academic Senate faculty representative, nominated by the Executive Committee of the Academic Senate  
Cal Poly Corporation representative, nominated by the Executive Director of the Cal Poly Corporation  
Non-MPP representative, nomination coordinated by the Associate Vice President for Human Resources  
Two faculty representatives, nominated by the Executive Committee of the Academic Senate, to serve on the Accommodation Review Board (ARB) only as needed  
Information Technology Services Representative, nominated by the Campus 508/Electronic and Information Technology Compliance Officer

The term of office shall be two years. The committee chair will be elected by the membership during the initial fall meeting, which will be convened by the prior chair. The chair shall serve a one-year term, with the possibility of being re-elected for one additional consecutive year. All members, including ex officio, are eligible to serve as chair.

### **Meetings**

Meetings shall be convened by the committee chair. The committee will meet at least once a year. Additional meetings may be scheduled if necessary.
